

1. A copy of KPWD Class-I & above registration (As per eligibility of Contractors mentioned in list of works).
2. The requisite Earnest Money Deposit (**EMD**) **through e-cash only**.
3. A copy of the valid **EPF Registration** Certificate.
4. Copy of the Income tax returns (ITR-V) filed for the year 2018-19 (Assessment year 2019-20)
5. A copy of the GST Certificate /Provisional GST Certificate/ GST No issued from competent Authority
6. The intending bidder should have satisfactorily completed at least one similar nature of single work (Such as Building Work) costing not less than 50% (work-1 **33.00 lakhs** Work – 2 **35.00 Lakhs**) of the amount put to tender during last five years (i.e., from 2015-16 to 2019-20). (The work done certificate should be obtained duly signed from an officer not below the rank of Executive Engineer of the concerned division shall be furnished). (Additional Weightage at 10% each year will be given for cost of work to bring it to 2019-20 level). The work done certificate shall be uploaded as per prescribed format enclosed as Annexure – I to the notification
7.
